MINUTES FOR THE TRADITION LADIES' GOLF ASSOCIATION MEETING

Meeting Date: Saturday, January 13, 1996

Place Held: The Tradition Golf Club

Members in attendance: 13 - Carolyn Mims, Helen Arnberg, Donna Fenlon, Joan Davis, Ruth Ellis, Margo Mohan, Carol Lane, Linda Mendicino, Trudy Hart, Pat Reed, Dorothy Smith, Rina Stevens, and Jane Thomas.

The meeting was called to order by the Chairman, Carolyn Mims. Matters discussed:

1. Amendments to the By-laws.
2. Ladies who joined without Tradition Golf Club memberships.
3. Membership procedures for new members joining after January 1, 1996.
4. Chairman appointments.

Carolyn Mims read the proposed By-law amendments. The Constitution and By-laws were then put before the members for general discussion. It was reiterated that all applicants must first be members of The Tradition Golf Club.

An amendment to the By-laws was proposed that applications for membership as of January 1, 1996 must be in writing. This would allow time for the Board to check membership and sponsors of new applicants. A motion was made by Pat Reed to accept the new by-laws. This motion was seconded by Jane Thomas, and passed by a voice vote.

The next order of business was women who had joined the Association during 1995 without a current membership to the Tradition Golf Club. Two names brought up for discussion were Linda Sipes and Helen Mutty. Both ladies are wives of Rangers. It was brought up that the Links Group is in the process of deciding how to give Rangers memberships at a specific club. Members of the Association have decided to suspended these ladies' memberships until this issue has been decided by the Links Group or they are able to show paid memberships in The Tradition Golf Club. Since Helen Mutty is currently playing with two ladies club, she will have to additionally decided which single club she will play with when the previous issue is resolved. A motion was made by Linda Mendicino to suspend Linda Sipes and Helen Mutty until the matter of their memberships has cleared up. This motion was seconded by Helen Arnberg and Carol Lane and passed by a voice vote.

Names of new applicants to the Association were then brought before the membership. They included Mary Bourke Milligan, Rose Kondur and Bobbie Callaway. Ms. Milligan and Ms. Kounder were informed that applications had to be received in writing as per the Association's By-laws. They will be notified in one week's time and allowed to play the following week if membership in the Tradition Golf Club and sponsorship by two current members is confirmed. Ms. Callaway is not a paid member of the Tradition Golf Club therefore cannot be considered for membership. Pat Reed motioned to accept the membership's decisions on these ladies' applications. This was seconded by Ruth Ellis and approved by a voice vote.

Carolyn Mims offered to call or write each of the ladies above and offer an explanation of her pending membership applications. Carolyn Mims will also bring up our current membership procedures during meetings she has planned on Monday, January 15, 1996 with Robert Spangler in the morning and Corporate Headquarters in the afternoon. These meetings were originally set up to discuss tee times and outings planned by both the Men's and Ladies' leagues.

The last order of business was Carolyn Mims' appointments for additional Chairmen. Linda Mendicino was appointed Ringer Board Chairman with Trudy Hart as Ringer Board Co-Chairman. Marjorie Yacullo will be approached to take the position as Social Chairman. Dorothy Smith has agreed to accept the position as Social Co-Chairman. Carolyn Mims will announce the Invitational Chairman when the group meets on Thursday, January 18, 1996.

With all orders of business completed the meeting was adjourned.

MINUTES FOR THE TRADITION LADIES' GOLF ASSOCIATION MEETING

Meeting Date: Monday, August 5, 1996

Place Held: The Tradition Golf Club

Members in attendance: 17 - Helen Arnberg, Millie Baldea, Caye Branca, Edie Brand, Genie Burg, Joan Davis, Ruth Ellis, Joanne Foster, Trudy Hart, Linda Mendicino, Mary Bourke Milligan, Carolyn Mims, Margo Mohan, Becky Parrott, Dorothy Smith, Nan Smith and Jane Thomas.

The meeting was called to order by the Chairman, Carolyn Mims. Matters discussed:

1. Guests on League day
2. Tips for cart people
3. Members attendance in either League tournaments or Interclub tournaments
4. Miscellaneous items; fundraising, 9 Hole Leagues, & upcoming events
5. By-laws in regard to how officers of the league are selected

A financial report was read by Margo Mohan. Total inflows since January 1996 were \$ 1408.95 and total outflows were \$925.63. The member guest used \$129.63 from membership funds leaving the League with a balance of \$ 483.32 in the treasury.

The first order of business was guests. Two scenarios were offered. The first proposed that prospective members be allowed to play one Thursday with the League. These guests would have to either play with a sponsor or have a sponsor call the president for clearance. The second would allow house guests to play if a member had called for them 48 hours prior to play and there was still space available after giving priority to members. A motion was made by Jane Thomas to allow prospective members to play with the League. This motion was seconded by Trudy Hart, and received a vote of 10. A second motion was made by Nan Smith to allow no prospects or guests to play on League days. This was seconded by Genie Burg and received a vote of 7. The motion to allow prospective members to play was passed by a majority vote of 10 to 7.

The next order of business was tips for the cart people. Carolyn Mims had been told that individual tips presented some confusion on Thursdays. The League was asked to put all tip money together in order to speed up loading the carts and getting members out on the course.

Dot Smith made a motion that the League collect tips at the same time as golf fees. This was seconded by Edie Brand and passed by an unanimous voice vote.

Members who represent the league in Interclub tournaments were discussed next. They would like to be counted present on Thursday so they will be eligible for prizes at the end of the year. Due to scheduling problems with the Links groups most Intermurals have been on League day. Dot Smith made a motion to count these days as League attendance. This was seconded by Margo Mohan and passed by an unanimous voice vote. Dates of attendance would have to be verified and given to Margo Mohan to update attendance records.

Carolyn Mims then asked if everyone was satisfied with weekly games and a clap of appreciation was given to Mille Baldea for all her work with weekly tournament play.

Methods to raise money were brought up at this time. Normally, the MBI would require funding through the League treasury. Jane Thomas stated that the Tradition would be taking a bye this year because times available for play were only in November and December. Members still had to consider moneys to cover the Christmas party, end of the year gifts of recognition and to carry the bank account over to next year. Trudy Hart made a motion that members, whether they show up or not, donate \$ 1.00 per week for a four week period starting September 1st. This was seconded by Mary Bourke Milligan and passed by a unanimous voice vote.

Under new business, an interest was voiced in a nine hole day or evening league by two members, Helen Arnberg and Caye Branca. Other members wondered if they could belong to both the regular League and a nine hole league. Carolyn said she would talk to Robert about the possibilities of any of these and get back to the membership with details.

The power of the President was then put on the table for discussion. It was decided that although the league was a democracy, there were times when the President and Board of Directors had to make certain decisions for the League. These offices were discussed in terms of leadership, selection and how time was allotted by a working vs. a non-working officer.

Jane Thomas motioned that a committee be appointed to put together a slate of officers for a vote by the League. This would be headed by a chairman who either volunteered or was appointed by Carolyn Mims. This was seconded by Mary Borke Milligan and passed by an unanimous voice vote of the members. Volunteers were asked to submit their names to Carolyn Mims after the meeting.

The Holiday party was brought up at this time. Different ideas were discussed by the membership; dinner vs. lunch, etc.. Linda Mendicino suggested that members who did not attend this meeting may want to be involved in its' planning. Carolyn Mims asked if there were any volunteers interested in running this event. Jane Thomas volunteered to head the planning committee and Mary Borke Milligan volunteered to help her.

Miscellaneous business included a few items. Carolyn Mims asked that a copy of these minutes be given to all members not attending the meeting. Suggestions were made on how future business would be brought before the membership and voted on. This included discussing items one week and voting on the next, calling meetings after League play and scheduling regular monthly meetings. Slow weekly play was also brought up. Members talked about ways to speed up play and to play ready golf.

With all orders of business completed the meeting was adjourned.

**THE TRADITION LADIES GOLF ASSOCIATION
CONSTITUTION AND BY-LAWS**

The TRADITION LADIES GOLF ASSOCIATION is organized for weekly play of golf and tournaments as designed by the **LADIES ASSOCIATION**.

Membership is open to 48 Lady Members, from eighteen (18) years of age or older, of **THE TRADITION GOLF CLUB**. Members are defined as those who pay their annual dues to **THE TRADITION GOLF CLUB**.

BY-LAWS:

- 1. OFFICERS -** The duly selected officers are to serve (1) term of office from January through December.
 - A.** The **Chariman and Co-Chairman** are selected by **alphabetical progression** from the membership list.
 - B.** All other officers shall be appointed by the **Chairman**.
 - C.** All officers shall comprise the **Board of Directors**.

- 2. DUES :** Yearly dues are **\$15.00** to be paid by January 15th, unless there is an extenuating circumstance. Dues may be increased with a majority vote of the membership at any regular meeting.

PRIZE MONEY- \$2.00 per Player (weekly).

- 3. MEMBERSHIP -**
 - A.** Limited to 48 Players.
 - B.** Application for membership shall be proposed by two (2) active members and presented in writing to any **Board** member for approval. Approval shall mean a majority vote of the **Board**. Upon approval by the Board, the application shall be presented to the general membership for a vote. A majority vote of this membership is necessary for approval.

- 4. HANDICAPS -** Players must have a handicap to play.

- 5. WEEKLY PLAY-**
 - A.** Play is to be held on **Thursday** of each week, with a show up time **30 minutes** prior to Tee Time.
 - B.** Six (6) or more players are required to constitute a tournament.
 - C.** To be eligible to play, players must sign up **48 hours** prior to Tee Time.

**By-Laws
The Tradition Ladies Golf Association**

- D. Any player unable to play must notify an officer of cancellation **48 hours** prior to Tee Time.
- E. The **Tournament chairman** will plan weekly play and determine the prize distribution of the day.
- F. All adjusted game scores are to be posted immediately after play by each member. Chip-ins and Birdies only apply on Ladies Day.
- G. Posting on Ringer Board will be handled by the **Ringer Board Chairman**.

6. TOURNAMENTS:

A. **Myrtle Beach Ladies Golf Invitational**

All members of the Ladies Association are eligible to play with the following restrictions:

- 1. The **Club's Invitational Representative** shall have the right to play in all events, if she so chooses.
- 2. If at such a time the field is over subscribed, and a cut is necessary, it will be done in the following order:
 - a. **Volunteers** will be requested.
 - b. Members who have not participated in **50%** or more weekly tournaments.
 - c. **By order of sign up.**

B. **Member/Guest** - Shall be played to 80% of full handicap.

7. SPECIAL AWARDS:

- A. To be eligible for awards at the end of the year, a member must play in at least **50 %** of the weekly tournaments.
- B. Under mitigating circumstances Article 7. A will be waived due to Physical, Self or immediate family problems.
- C. Awards will be given for Low Ringer Board, Chip-Ins, Birdies, Low Gross, Low Net, Low Putts and the most improved handicap during the year.

8. AMENDMENTS:

- A. The **By-Laws of The Tradition Ladies Golf Association** are established for the purpose of maintaining an efficient and equitable administration for the membership. They also serve as the basis for understanding the general duties of each officer and chairman and for establishing ease and continuity when newly elected members assume various offices.
- B. The **By-Laws** may be appended, repealed or supplemented by the Board of Directors after approval of a majority vote of the membership at a meeting held in accordance with the provisions contained herein.
