THE TRADITION LADIES' GOLF ASSOCIATION BY-LAWS

ARTICLE 1: NAME

The name of the organization shall be The Tradition Ladies' Golf Association.

ARTICLE 2: OBJECT

The object of this association is to promote the game of golf by providing league play for the mutual benefit and enjoyment of the members.

ARTICLE 3: MEMBERSHIP

- A. Membership shall be limited to 65 Lady Members at least eighteen years of age who are Tradition Residents and members of The Tradition Golf Club.
 - 1. Members are defined as those who pay their annual dues to The Tradition Golf Club and TLGA.
 - 2. Residents of the Tradition that have been granted membership privileges as a condition of employment at The Tradition Golf Club may also become members of TLGA.*
 - *The only exception to the residency requirement will be for those who were members of TLGA on or before October 9, 1997.
- B. Members must have a USGA 18-hole Handicap Index to play in weekly tournaments and keep their handicaps current at The Tradition Golf Club.
 - 1. All first-time members must have a USGA Established Handicap Index of 40.0 or less.
 - 2. Handicap Index should be based on a minimum of ten 18-hole scores as recorded in the Tradition Club computer and/or proof of USGA Index.
- C. An **Active** member is required to play at least 12 league day tournaments a year. (A year is defined as beginning January 1 and ending December 31.)
 - 1. League day play cancelled either by the Club or the League Day Chairperson will count toward the above requirement.
- D. An Associate member:
 - 1. is one who plays less than 12 weekly league days a year (January 1 through December 31.)
 - 2. must pay annual dues.
 - 3. may play as an alternate on league day when space is available and will be included in weekly prize money.
 - 4. shall have no voting rights. (Effective January 1, 2002.)

ARTICLE 4: ELECTION OF OFFICERS

A. The President will appoint a Nominating Committee for the purpose of submitting a slate of officers to be posted and/or delivered to every Active Member no later than November 1. A sign-up sheet will be posted in the Member Room, by September 15, for any Active Member interested in

- serving on the Board. Ballots will be distributed, collected, and counted by this Committee by November 30.
- B. The President of the current Board will convene a meeting with the incoming Board to propose the following year's budget to be presented to the Active Members for vote at the last annual Membership Meeting.
- C. The new officers shall be installed at the Awards Luncheon/Dinner Meeting.

ARTICLE 5: OFFICERS

- A. The Officers shall be elected by ballot by a simple majority of the Active Members.
- B. The Officers shall consist of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, and Historian.
- C. The 2nd Vice President shall be elected to serve on the Board for three consecutive years.
 - 1. The first year as 2nd Vice President.
 - 2. The second year as 1st Vice President.
 - 3. The third year as President.
- D. The term of each office shall be one year.

ARTICLE 6: DUTIES OF THE OFFICERS

- A. President shall preside at all meetings and approve all activities of the Association. She shall appoint any special chairpersons or committees she deems necessary including a yearly internal auditor of all funds.
- B. 1st Vice President will be in charge of the weekly league day tournaments, assist in any other tournaments, and appoint a Handicap/Rules Assistant. She will assist the President at all times in the fulfillment of her duties and shall preside at all meetings and events in the absence of the President.
 - 1. The Handicap/Rules Assistant shall assist with weekly league play as necessary. (Effective January 1, 2002.)
- C. 2nd Vice President will be in charge of all league-sanctioned events. She will assist the President and 1st Vice President in the fulfillment of their duties and will preside at all meetings and events in the absence of the President and 1st Vice President.
- D. Secretary shall keep minutes of all meetings, attendance, maintain a current membership roster, handle any correspondence with the Association and any other duties assigned by the President.
- E. Treasurer shall handle all finances of the Association and keep a record of such. She shall deposit all monies in a local bank in the name of the Association. She or the President should sign all checks. She shall report on the financial condition of the Association at any meeting thereof. At year-end, she shall prepare a budget for the ensuing year and see that a minimum of \$60 is available for transfer to the new Treasurer and submit the records for audit. Excess funds at year's end will become part of the next year's budget whose use will be approved by full membership during budget approval at the first meeting.

- F. **Historian** shall be responsible for the league scrapbook, the taking of pictures for all special events, providing information to the Newsletter, and maintaining the bulletin board.
- G. Vacancy on the Board
 - 1. The Board may appoint a substitute to fill any vacancy in an elected office until an election by the Active Members can be held.

ARTICLE 7: DUES/FEES

The Board shall determine the annual dues based on the proposed budget for the coming year (January 1 through December 31). Annual dues are to be paid by January 15.

ARTICLE 8: LEAGUE DAY PLAY

- A. Play is to be held once weekly.
- B. Eight (8) or more players are required to constitute a tournament.
- C. Players must sign up 72 hours prior to league day.
- D. Cancellations must be made 24 hours prior to league day.
- E. No Shows and excessive cancellations will be referred to the Board for further action.
- F. The 1st Vice President, as League Day Chairperson, will plan weekly play and determine the prize distribution of the day.
- G. All adjusted game scores are to be posted.

ARTICLE 9: LEAGUE TOURNAMENTS

- A. **Member-Guest** will be open to all members and will be played to full handicap. Guests must have a current USGA Handicap Index.
- B. **Member-Member** will be open to all members and will be played to full handicap.
- C. Ringer Tournament will be a two-day net tournament open to all members. (Effective January 1, 2002.)
- D. **President's Cup** will be open to members having played 12 league days prior to September 1, will be played to full handicap, and will be scheduled after September 1.

E. League Championship will be open to members having played 12 league days prior to September 1; will be a single elimination, gross tournament played in flights during regular weekly league play; and will be the last tournament of the year. (Effective January 1, 2002.)

ARTICLE 10: LEAGUE SANCTIONED TOURNAMENTS

Annually the Board will review and approve participation in all league-sanctioned events. Participation will count towards attendance if played on a scheduled league day.

ARTICLE 11: MEETINGS

There shall be a minimum of three league meetings held each year. Meetings shall be conducted under basic Robert's Rules of Order.

ARTICLE 12: SPECIAL AWARDS

- A. To be eligible for awards at the end of the year, members must play in at least 50% of the weekly league day tournaments by November 30.
- B. Awards will be given for Overall Low Gross, Overall Low Net, Lowest Gross, Lowest Net, Lowest Putts, Low Ringer Board, Most Birdies, Most Improved Handicap, and Holes-in-One.
- C. Birdies, Eagles, and Holes-in-One only apply on league day and leaguesanctioned tournaments. Birdies and eagles must be holed out for inclusion in league statistics and awards.
- D. Birdie and eagle awards may be given to all regardless of times played during the year.
- E. The Board may include other awards at their discretion.

ARTICLE 13: AMENDMENTS

- A. The By-Laws of the Tradition Ladies' Golf Association are established for the purpose of maintaining an efficient and equitable administration for the membership. They also serve as the basis for understanding the general duties of each officer and chairperson and for establishing ease and continuity when newly elected members assume various offices.
- B. The By-Laws may be appended, amended, repealed, or supplemented by the Board after approval of a two-thirds vote of the Active Membership at a meeting held in accordance with the provisions contained herein.

MEETING MINUTES JANUARY 11, 2001

President Bobbie Fleiss called the meeting to order and welcomed in excess of 40 members to the first league meeting of 2001 and introduced our newest Association Member, Pat D'Amato. A TLGA Calendar of Events was passed out to each member. The booklet contains: list of this year's Executive Board; list of probable members (based on last year's membership); and monthly calendar of League Play, League Meetings, TLGA Tournaments, MB Invitational, State Tournaments, and the Awards Luncheon.

Old Business

The membership was reminded of the cancellation policy for regular League Play. Individuals are responsible for the cart fee (if the Pro Shop chooses to assess it) when canceling their participation on Wednesday or Thursday. Cancellations are accepted until Tuesday evening prior to Thursday's scheduled play. Adherence to this policy is a courtesy to fellow members as well as to the Weekly Tournament Chair.

The TLGA has cancelled membership in the Palmetto League due to a lack of participation last year. Their league schedules play the last Thursday of the month which conflicts with our normal League Day.

The membership was reminded of the requirement of playing at least 12 Thursday League Days to be eligible for participation in both the President's Cup and the Club Championship Tournaments.

New Business

Treasurer Debbie Massie presented the proposed 2001 budget. Dues will remain at \$25 for the year and once again the Pick-A-Pro game is voluntary at \$5. Clare Kelly, last year's winner received free dues for 2001. In response to Bev Brown's question, Debbie explained that the carry-over funds (\$385.02) were disbursed among the scheduled Tournaments for 2001. Increases in expenses include: year-end tips for the Tradition Hospitality Staff (+\$50); Member Member Tournament (+\$125); Member Guest Tournament (+\$75); Waccamaw Neck Match Play Challenge (+\$150); and Susan G. Komen Rally for A Cure (+\$250).

Motion to Approve the Budget as Presented – Maureen Lempert; Seconded – Bev Brown; Carried – Unanimously

Bobbie asked the membership to consider signing up for a Committee to review and propose revisions to the By-Laws. All those signing up may not be selected to keep the size of the committee reasonable. The committee will select a chairperson and the chair will report the committee's review and proposal to the Executive Board.

New Business (continued)

Secretary April Kuruc announced that the Executive Board was looking into the development of a web page similar to the Tradition Men's League. She will meet with Frank Gambeski to learn how to create and maintain a web page with the intent that it will be a helpful, informative tool for the membership to use. Members will be alerted when the page is available.

First Vice President Ginni Swenson discussed the 2001 Special Tournaments, dates, and chairs. They are as follows:

Additionally, on Saturday, August 4th, the Pro Shop, in conjunction with the Men's League, will host a Sadie Hawkins Tournament. Ginni distributed a sign-up sheet for those interested in helping the chairs with the tournaments throughout the year.

Second Vice President Patsy Roberson presented her plans for weekly league play to the membership. Her plans are to:

- keep the games and scoring simple
- post the game selected on the sign-up sheet for each week
- follow a prescribed plan for games Wk 1, individual game; Wk 2, two-man team game; Wk 3, four-man team game; Wk 4, match play
- institute a rotating "closest-to-the-pin" pot weekly voluntary, \$1
- inaugurate a quarterly "pick a partner" Thursday in response to high interest in the Member/Member type tournament

Motion that all birdie putts must be holed out to count for the Birdie Tree and year-end awards – Maureen Lempert. There was no second and discussion ensued regarding Match Play and a conceded putt which can not be refused and not holed out. **Resolution** was that Bobbie would examine Match Play rules and come back with a ruling prior to the next League Match Play date (January 25th).

Gail McLaughlin will be Committee Chair for the Annual Awards Luncheon to be held at Pawleys Plantation on Wednesday, December 5th. The Executive Board has decided that the luncheon should be a stand-alone day for celebrating our achievements and, therefore, has scheduled the last League Meeting of the year for Thursday, December 13th. At that meeting, we intend to discuss lessons learned, things that worked, things that didn't, introduce the 2002 Board, and ask the membership to provide the new Board with concerns, suggestions, ideas, and enhancements as they begin their term of office.

New Business (continued)

Sharon Delaney and Clare Kelly will manage the Ringer Board and the Birdie Tree in 2001. Bobbie explained that the Ringer Board starts with a member's first league play of the new season and is updated hole by hole after each Thursday's round to track a player's improvement over the course of the year. (Last year's most improved was Ginni Swenson!) Each time a member has a birdie, a little birdie is added to the tree. Both of these accomplishments are celebrated at the year-end Awards Banquet.

Trudy Hart and Sandy Blais will co-chair the Myrtle Beach Invitationals this year. Sandy reported that the first date is March 27th at Rolling Hills and tournaments run through December 4th. The price is usually in the low \$20s and includes cart fee, breakfast (generally), and prizes. The Tradition and the TLGA will host/hostess an Invitational this year on July 17th. Volunteers will be needed for all avenues – breakfast goodies, making nametags, making goodie bags, greeting, computing scorecards, and generally making participants feel welcome and comfortable. Bobbie reminded the membership that the MB Invitationals allot 50 cents per bag for the bag boys and that when we participate at other clubs perhaps we would want to be more charitable.

Connie Hazard will continue as chair of the State Tournaments for the TLGA in 2001. These tournaments are scheduled the second Tuesday of the month, are played in flights, and all levels of play are welcome; however, the maximum stroke allowance is 36. All tournaments will be posted in the Member Room one month prior to the Tournament – you have two weeks to sign up and pay. The price is \$15 which includes participation fee, lunch, and prizes. Cart fees are paid upon arrival at the tournament. All members, at all levels, in all flights, are encouraged to participate – it's a great way to meet other lady golfers from the state, to play phenomenal courses throughout South Carolina, and to improve your game in tournament play.

Bobbie announced that in accordance with the By-Laws three meetings are required annually and are scheduled for May 17th and December 13th.

Open Discussion

Attending members were asked if there was any further new business.

Motion to eliminate the carry around rule during weekly tournaments with the understanding that we will adhere to this rule at other courses that require it – Joan Davis; **Seconded** – Veronica Bucello; **For** – 16; **Against** – 16; **Abstained** – 3. **Not Carried**.

Having met with Robert in anticipation, Bobbie proposed the following: Hole 7 – create a drop area to the right at the end of the fairway/rough which will be about a 20-foot carry across the hazard; Hole 9 – create a drop area to the left near the tree but not impeded by the tree which will be the shortest carry across the environmental area; Hole 14 – to the right at the end of the fairway providing about a 20-foot carry; Hole 15 – to the area near the blue tees.

Motion to have Bobbie work with Robert Spangler, Pro, to establish new drop areas for holes 7, 9, 14, and 15; **Seconded** – Gail Lee; **Carried by the majority.**

Motion to implement the proposed drop areas immediately with the understanding that the grounds crew will improve the conditions of those new drop areas in the future, but immediately allowing a choice of both the current carry-around option or the new drop area with no additional stroke – Debbie Massie; **Seconded** – Rachel Coletti; **Carried by the majority.**

Membership requested picture of proposed new drop areas – Mary Graef.

Motion to adjourn – Maureen Lempert; **Seconded** – Gail McLaughlin.

TLGA Executive Board Meeting Minutes October 11, 2001

The meeting was called to order at 11:25 a.m.

The minutes of March 27th were approved.

As the first order of business, the Board decided that no further action would be taken regarding the proposal that the By-Laws be amended to provide a disclaimer for accidental disability resulting in a member not meeting the approved 12-play limit to maintain active membership. According to the By-Laws, members who did not play 12 times in 2001 are automatically moved to the "associate" member category if they choose to rejoin in 2002. Further, we can accept 65 Active members. All dues are payable by January 15th.

Bobbie gave the Board an update from the Nominating Committee who will distribute ballots beginning today. All Active Members will be requested to sign for their ballot to ensure complete distribution to voting members. Ballots must be returned by November 30th. The slate of officers for 2002 is:

Bobbie was approached by a member of the Ladies' Association at River Club about our interest in scheduling a "home and home" tournament in 2002. The proposal is that perhaps this could be scheduled for two days in January; be a better ball tournament; pair one River Club player with one Tradition Club player; be limited to 16 players from each club; be self-sustaining in that there would be a nominal entry fee (\$5?) to cover cheese and crackers and small prizes. The Board was in total agreement with the idea, but would not schedule it for League Day. Bobbie will pursue with Robert to see if we could get "cart fees only" and then she will discuss further with River Club.

The Annual Awards Luncheon is scheduled for Wednesday, December 5th. Gail McLaughlin is chair with Mary Graef assisting. The menu has not yet been selected, but they are working on table decorations. Debbie clarified that the budget is \$500 and that the members pay for their own lunch and an additional \$2-\$3 to help defray the costs of the prizes. Ginni and Bobbie were given copies of the prizes from last year - Low Gross, Low Net, Low Putts, Low Ringer Board, Most Improved Handicap, Most Birdies, and those who Broke 100, 90, 80 for the first time in League Play. Mention is made, but no prize awarded, for Most Chip-Ins. This year we are adding prizes for Overall Low Gross and Overall Low Net. Cut-off date for prizes is November 29th.

To date, the leader in the Pick-a-Pro Contest is Clare Kelly. The contest cut-off date is November 18th. The winner of this is also announced at the Awards Luncheon and is given "free" League Membership for 2002. We had 19 players participate this year which netted the League \$70. The Board agreed to offer the contest again in 2002. Bobbie will follow up.

Ginni reported that the Club Championship produced a net income of \$165.70 and the President's Cup netted \$89.11 for the League Treasury. Suzanne Strasser has the Susan G. Komen Tournament well in hand with 88 players signed up and a waiting list. Suzanne will include Bobbie, Ginni, and Debbie in the next planning meeting.

Debbie gave the Treasurer's Report. The current checkbook balance is \$984.38 and if we continue on budget, she expects approximately \$430 for carry over. The Board agreed to carry over the full amount to the 2002 season.

As New Business, Debbie raised the following issues:

- 1. The 2nd Vice President should be responsible for keeping the inventory of "left over" gifts, prizes, tickets, wrapping paper, etc., for the year. It will make it much easier for Tournament Chairs to have one place to go to determine what is available before having to buy things. The Board agreed. Ginni (as Tournament Chair this year) will provide these materials to the 2nd Vice President in 2002.
- Going forward the Treasurer should provide a disk back-up of all league financials to the President. The Board agreed. Debbie will purchase disks and make back-up materials for Ginni.
- 3. A "team uniform" idea will be explored and brought to the Membership for vote. Perhaps we could offer a selection of two shirts and a visor that would be embroidered with the Tradition Logo and TLGA. The visors might even be embroidered with the individual's name under TLGA. The Board agreed. Ginni will pursue this with Robert and discuss his ability to either keep an inventory in-house or talk with his supplier to determine styles and colors that would always be available.

The next Board Meeting is scheduled for Monday, November 26th at 3 p.m.

The next League Meeting will be December 13th.

The meeting was adjourned at 12:30 p.m.
