THE TRADITION LADIES' GOLF ASSOCIATION BY-LAWS

ARTICLE 1: NAME

The name of the organization shall be **The Tradition Ladies' Golf Association**.

ARTICLE 2: OBJECT

The object of this association is to promote the game of golf by providing league play for the mutual benefit and enjoyment of the members.

ARTICLE 3: MEMBERSHIP

- A. Membership shall be limited to 65 Lady Members at least eighteen years of age who are Tradition Residents and members of The Tradition Golf Club.
 - 1. Members are defined as those who pay their annual dues to The Tradition Golf Club and TLGA.
 - 2. Residents of the Tradition that have been granted membership privileges as a condition of employment at The Tradition Golf Club may also become members of TLGA.*
 - *The only exception to the residency requirement will be for those who were members of TLGA on or before October 9, 1997.
- B. Members must have a USGA 18-hole Handicap Index to play in weekly tournaments and keep their handicaps current at The Tradition Golf Club.
 - 1. All first-time members must have a USGA Established Handicap Index of 38.7 or less, resulting in a handicap of 40 or less.
 - 2. Handicap Index should be based on a minimum of ten 18-hole scores as recorded in the Tradition Club computer and/or proof of USGA Index.
- C. An **Active** member is required to play at least 12 league day tournaments a year. (A year is defined as beginning January 1 and ending December 31.)
 - 1. League day play cancelled either by the Club or the League Day Chairperson will count toward the above requirement.
- D. An **Associate** member:
 - 1. is one who plays less than 12 weekly league days a year (January 1 through December 31.)
 - 2. must pay annual dues.
 - 3. may play as an alternate on league day when space is available and will be included in weekly prize money.
 - 4. shall have no voting rights. (Effective January 1, 2002.)

ARTICLE 4: ELECTION OF OFFICERS

A. The President will appoint an Election Committee for the purpose of submitting a slate of officers to be posted and/or delivered to every Active Member no later than November 1. A sign-up sheet will be posted in the Member Room, by September 15, for any Active Member interested in serving on the Board. Ballots will be distributed, collected, and counted by this Committee by November 30.

- B. The President of the current Board will convene a meeting with the incoming Board to propose the following year's budget to be presented to the Active Members for vote at the last annual Membership Meeting.
- C. The new officers shall be installed at the Awards Luncheon/Dinner Meeting.

ARTICLE 5: OFFICERS

- A. The Officers shall be elected by ballot by a simple majority of the Active Members.
- B. The Officers shall consist of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, and Historian.
- C. The term of each office shall be one year.

ARTICLE 6: DUTIES OF THE OFFICERS

- A. **President** shall preside at all meetings and approve all activities of the Association. She shall appoint any special chairpersons or committees she deems necessary including a yearly internal auditor of all funds.
- B. 1st Vice President will be in charge of the weekly league day tournaments, assist in any other tournaments, and appoint a Handicap/Rules Assistant. She will assist the President at all times in the fulfillment of her duties and shall preside at all meetings and events in the absence of the President.
 - 1. The Handicap/Rules Assistant shall assist with weekly league play as necessary. (Effective January 1, 2002.)
- C. 2nd Vice President will be in charge of all league-sanctioned events. She will assist the President and 1st Vice President in the fulfillment of their duties and will preside at all meetings and events in the absence of the President and 1st Vice President.
- D. **Secretary** shall keep minutes of all meetings, attendance, maintain a current membership roster, handle any correspondence with the Association and any other duties assigned by the President.
- E. Treasurer shall handle all finances of the Association and keep a record of such. She shall deposit all monies in a local bank in the name of the Association. She or the President should sign all checks. She shall report on the financial condition of the Association at any meeting thereof. At year-end, she shall prepare a budget for the ensuing year and see that a minimum of \$60 is available for transfer to the new Treasurer and submit the records for audit. Excess funds at year's end will become part of the next year's budget whose use will be approved by full membership during budget approval at the first meeting.
- F. **Historian** shall be responsible for the league scrapbook, the taking of pictures for all special events, providing information to the **Newsletter**, and maintaining the bulletin board.
- G. Vacancy on the Board
 - 1. The Board may appoint a substitute to fill any vacancy in an elected office until an election by the Active Members can be held.

ARTICLE 7: DUES/FEES

The Board shall determine the annual dues based on the proposed budget for the coming year (January 1 through December 31). Annual dues are to be paid by January 15.

ARTICLE 8: LEAGUE DAY PLAY

- A. Play is to be held once weekly.
- B. Eight (8) or more players are required to constitute a tournament.
- C. Players must sign up 72 hours prior to league day.
- D. Cancellations must be made 24 hours prior to league day.
- E. No Shows and excessive cancellations will be referred to the Board for further action.
- F. The 1st Vice President, as League Day Chairperson, will plan weekly play and determine the prize distribution of the day.
- G. All adjusted game scores are to be posted.

ARTICLE 9: LEAGUE TOURNAMENTS

- A. **Member-Guest** will be open to all members and will be played to full handicap. Guests must have a current USGA Handicap Index.
- B. **Member-Member** will be open to all members and will be played to full handicap.
- C. Ringer Tournament will be a two-day net tournament open to all members. (Effective January 1, 2002.)
- D. **President's Cup** will be open to members having played 12 league days prior to September 1, will be played to full handicap, and will be scheduled after September 1.
- E. Club Championship will be open to members having played 12 league days prior to October 1; will be a gross tournament played in flight, except the Championship Flight, which is open to all eligible members, and will be the last tournament of the year. (Effective January 9, 2003.)

ARTICLE 10: LEAGUE SANCTIONED TOURNAMENTS

Annually the Board will review and approve participation in all league-sanctioned events. Participation will count towards attendance if played on a scheduled league day.

ARTICLE 11: MEETINGS

There shall be a minimum of three league meetings held each year. Meetings shall be conducted under basic Robert's Rules of Order.

ARTICLE 12: SPECIAL AWARDS

A. To be eligible for awards at the end of the year, members must play in at least 50% of the weekly league day tournaments by November 30.

- B. Awards will be given for Overall Low Gross, Overall Low Net, Lowest Gross, Lowest Net, Lowest Putts, Low Ringer Board, Most Birdies, Most Improved Handicap, and Holes-in-One.
- C. Birdies, Eagles, and Holes-in-One only apply on league day and leaguesanctioned tournaments. Birdies and eagles must be holed out for inclusion in league statistics and awards.
- D. Birdie and eagle awards may be given to all regardless of times played during the year.
- E. The Board may include other awards at their discretion.

ARTICLE 13: AMENDMENTS

- A. The By-Laws of the Tradition Ladies' Golf Association are established for the purpose of maintaining an efficient and equitable administration for the membership. They also serve as the basis for understanding the general duties of each officer and chairperson and for establishing ease and continuity when newly elected members assume various offices.
- B. The By-Laws may be appended, amended, repealed, or supplemented by the Board after approval of a two-thirds vote of the Active Membership at a meeting held in accordance with the provisions contained herein.

By-Law change Article 10

Gail stated the wording should changed due to league sanctioned play being conducted on Thursday, Weds and Tues. This was discussed, but no motion was made to change the phrase. It was felt by the membership that scheduled league day accommodated the change in play days.

Blue Tee [Results of test and Discussion]

J. Renault started the discussion with a statement of how she enjoys playing from the Blue Tees. She feels teams move along faster. Judy Gambeski enjoys golf more from the Blue Tees. R. Coletti wanted to know; if the Blue Tee players improve can they move back to the red tees? The answer is yes. They have a yearly commitment to the Blue Tees. Connie Hazard has already scheduled member/guest. They have one player[blue tee] who will be playing from the reds this year. Guests do not have a blue tee handicap. Any tournaments we run will be played on red tees with the exception of identified Blue Tee participants. Maureen L. said match play / interclub events are played from the red tees. Danny Jennings questioned; why are we playing the Susan G. Komen tournament? Gail answered that at the 11/7/02 membership meeting it was voted to continue this tournament as self-sustaining. The vote passed 28 to 6. It will be held on September 25th. Gail stated the nine hole ladies will be working on and playing in the tournament

Sandy Blais mentioned Friends of Santa is posted for signup. It will be a four person team event, on 6/21/03 with a shot gun start. Ginni mentioned we should make sure the gold tees players have an accurate handicap. Sandy has already discussed multiple tee handicaps with Robert, TGC pro.

Congratulations were given to the new 2004 Board; President, April Kuruc, 1st Vice President/Weekly games, Debbie Massie, 2nd Vice President/Major Tournaments, Beverly Brown, Treasurer, Dot Ellison, Secretary, Joan Sheldon and current/new Historian, Betty Ruff.

The reading of the meeting minutes from May 1st was waived, motion by G. Swenson and 2nd by A. Kuruc. Current President, Gail McLaughlin was not able to attend the meeting. Current Secretary, Suzanne Strasser presented the agenda.

The Proposed Budget for 2004 was reviewed by current Treasurer, Pat Cocuzza.

The Year end tips for Golf staff were discussed for the proposed budget of 2004. A motion made by Ginni Swenson, 2nd by Beverly Brown increased the tips for 2004 from \$250.00 to \$300.00. Passed 31 to 3.

The carry over figure from 2003 was changed from \$950.00 to \$900.00. A Motion made by Debbie Massie, 2nd by Sharon Delaney was made to increase tips from \$250.00 to \$300.00 for the current year 2003. Passed 33 to 1. The previous breakdown was described by April Kuruc. The next topic was Myrtle Beach Invitationals. Trudy Hart advised that these tournaments have not had much attendance. Donna Culver raised the question; do we want to continue attending these club functions? Trudy said she would be attending a meeting for this group. She stated that if we do wish to play with this organization it will be time for us to sponsor a tournament. Several suggestions were made to use the carry over amount. Donna Culver, 2nd by Judy Gambeski made a motion to treat the Board members to the holiday luncheon. Defeated 31 to 3. Donna Culver would like to improve the presentation of the member/guest tournament with the purchase of table cloths. Debbie Massie stated that the sales of cookbooks at the holiday luncheon in 2002 allowed us to have such a large amounts of funds available to us. Pat Cocuzza stated that all chair-persons ran their committees well and made a profit on tournaments. The league also sold mulligans, rule books, etc. Debbie Massie, 2nd by Ginni Swenson motioned to move the \$100.00 [Misc fund for any tournament or events to reduce price] to be included in administrative funds. This would result in an Admin fund of \$595.00. Passed 35/0 [1 additional member arrived late].

Beverly Brown motioned, 2nd by Nancy Malara to approve the Proposed Amended 2004 Budget. Passed 34 to 1.

New Business was discussed: Bobbie Fleiss advised that a schedule for the Heritage, Pawleys Island, Tradition Tournament would be forth coming in January. The price would be approximately \$30.00.

Prior to the current board and new board meeting, several changes were to be made to the By Laws. Since the meeting, the current board is going to table the changes until the new board reviews these areas. Ginni wanted clarification regarding what possible changes were involved. The areas involved were; the ringer board and article 12 the prizes given out at the awards luncheon. Suzanne stated these are tabled until the New Board has a chance to review the By-Laws.

Ginni Swenson introduced a motion, 2nd by Rachel Coletti, a revision of our league's scoring system in 2004. If a player puts in a score on Thursday league play this would not be a Tournament round. Discussion followed; Pat D'Amato believes that weekly play is a competition, which awards prizes and is conducted by a committee. Dot Ellison asked if the weekly tournaments are not input as T scores what will be input for handicap purposes as T scores. April suggested a 3rd option of allowing the weekly tournament chairperson to identify for players when T score input is appropriate. Ginni has researched this with other clubs to determine how other groups on the Grand Strand are inputting their scores. Suzanne stated that within the USGA rules there is documentation which would clarify this issue. She requested this item be reviewed by the new board so that the membership could make an informed decision. Ginni, 2nd by Maureen tabled the motion for no vote at this time.

Health problems, not allowing someone who is ill to play in sufficient golf events [12] to maintain their active status, was mentioned by MaryAnn Kellar. April Kuruc's motion is; for the coming year 2004, members which have experienced disabilities/major illnesses can remain active members for the year 2004. 2nd by Mary Ann Kellar. Discussion began. Pat D'Amato advised out of 7 ladies who have become associates 6 have had health related problems. Lucy Hajec wanted to know how we distinguish among players that can keep their active status and those that become associates. Lucy suggested the board have the deciding vote on who qualifies. The initial motion of a one time health ruling for 6 members keeping their active status for 2004 was passed 34 to 1. Ginni presented an adjunct to the motion, 2nd by Rachel that the new board should formulate criteria for what medical reasons could be used for not playing 12 times and still keeping your active status. Passing 34 to 1.

Motion to adjourn was made by Gail Lee, 2nd Rachel Coletti. passing 35 to 0.
